



- According to initial estimates, year-over-year GDP growth slowed in the fourth quarter in both the U.S. and Europe. Growth in Europe and Japan continues to lag the U.S. significantly.
- The U.S. unemployment rate ticked down to 4.0% in January following upward revisions to job growth in prior months.
- Year-over-year U.S. core inflation has slowly moderated but remains above Federal Reserve targets. Inflation in Europe has leveled off to a reduced but still above average level, while inflation in Japan is relatively low.
- U.S. industrial production growth improved in December and is now positive year-over-year, while year-over-year U.S. labor productivity growth has declined to 1.6% following moderate fourth quarter growth.



Housing/Construction	• Building permits were down -0.74% in December and have decreased -3.14% over the past year.
Consumer Confidence	• The Consumer Confidence Index decreased to 104.1 compared to 109.5 in the previous month.



Rolling 5-Year Return Differential Russell 3000 Growth minus Russell 3000 Value






- The broad bond market, as represented by the Bloomberg U.S. Aggregate Bond Index, returned +0.53% in January, with the index's largest subsectors producing positive returns, including U.S. Credit up 0.56%, U.S. Government securities up 0.52% and agency mortgage-backed securities (MBS) returning +0.51%. U.S. TIPS returned +1.29% but the asset class that performed best over the month was high yield, returning 1.37%. The lowest performer over the month, while still positive, was Global Treasuries ex.-U.S., returning +0.15%.
- 10-year government bond yields of select countries had mixed movements over the month with counties such as Germany and Italy seeing rates move higher by 11 bps and 4 bps, respectively. In other countries, 10-year yields in France were flat, while U.S. and U.K. yields were lower. In the U.S., the yield on the 10-year Treasury was down by 2 bps, from 4.57% to 4.55%.

In a reversal from the previous month, Municipal/Treasury ratios moved lower in January, with ratios across the curve decreasing. Front-end ratios saw the biggest decline, as 2-year ratios were lower by 332 bps monthover-month. Ratios remain below 5-year averages.

Fixed Income Spreads and TIPS Breakeven




- Investment grade corporate bond spreads were little changed in January, while high yield spreads declined. Credit spreads remain well below long-run averages.





- Revenue yields were little changed in January across markets. Dividend yields in Developed Markets moved lower while Emerging Market dividend yields moved higher. U.S. revenue and dividend yields remain well below international market levels.
- The Volatility Index (VIX), a measure of market expected equity volatility, was little changed in January and is close to the 20-year historical median. Lower VIX levels may be indicative of lower equity risk premiums.







Core Consumer Price Index (CPI): a measure of the aggregate price level in an economy, excluding certain volatile items.

Consumer Confidence Index (CCI): measures what consumers are feeling about their expected financial situation, whether that's optimistic or pessimistic.

Option Adjusted Spread (OAS): A bond's yield spread over comparable maturity government bonds, adjusted for any embedded options.

Real Disposable Personal Income: the amount of money that an individual or household has to spend or save after federal, state, and local taxes and other mandatory charges are deducted.

Real GDP: Real gross domestic product (GDP) is an inflation-adjusted measure that reflects the value of all goods and services produced by an economy in a given year, expressed in base-year prices.

Nonfarm payroll refers to the number of jobs in the private sector and government agencies. It excludes farm workers, private household employees, proprietors, non-profit employees, and actively serving military.

Revenue-to-Firm Value: Total Index Revenues of the past 12 months divided by the sum of equity market value and the value of total debt. This is a measure of total sales generated on the total value (debt plus equity) of firms in the index.

TIPS Breakeven: The inflation rate implied by the spread in yield between U.S. TIPS (Treasury Inflation Protected Securities) and nominal U.S. Government Bonds of equal maturity.

U.S. 3-Year Real Revenue Growth, Russell 3000 Non-Financials: For the Russell 3000 excluding financial firms, the percentage change in trailing 12-month inflation adjusted revenue over 12-month inflation adjusted revenue three years prior.

U.S. Cyclically Adjusted Earnings Yield: The 10-year average of annual, inflation adjusted earnings divided by the current inflation adjusted price of the S&P 500 index. This measure is the inverse of the Shiller CAPE Ratio.

YOY U.S. Productivity Growth: The year-over-year growth in real U.S. output produced per hour worked for non-farm workers.

CAPE Ratio: is a valuation measure that uses real earnings per share (EPS) over a 10-year period to smooth out fluctuations in corporate profits that occur over different periods of a business cycle.

Dividend Risk: refers to the risk of a stock's dividend being cut or eliminated, or to the risk to an option when a dividend is paid.

Dividend Yields: is a financial ratio that shows how much a company pays out in dividends each year relative to its stock price.

Eurozone: consists of those Member States of the European Union that have adopted the euro as their currency.

Municipal Yield: the annual return an investor receives on a municipal bond. It's calculated based on the bond's purchase price, coupon rate, and how long the investor holds the bond.

Treasury Yield: the interest rate the U.S. government pays on its debt securities, expressed as a percentage. It's also the annual return investors earn from holding a U.S. government security.

Capitalization/Style Returns: Capitalization/Style returns are based on the S&P Indexes. All values are cumulative total return for stated period including the reinvestment of dividends.
