

-	Global equities, as defined by the MSCI ACWI IMI, rose 0.94% in April despite a spike in market volatility during the first part of the month. While global equities experienced significant declines in the days following the "Liberation Day" reciprocal tariff announcement on April 2nd, global equities rose sharply and recovered early month losses after a 90-day pause on reciprocal tariffs (excluding China) was announced on April 9th. Consistent with the first quarter of 2025, international equities (MSCI ACWI ex USA IMI +3.76%) continued to outperform U.S. equities (Russell 3000® Index -0.67%) in April After underperforming in 1Q25, growth (MSCI ACWI Growth +3.05%) outperformed value (MSCI ACWI Value -1.16%) during the month. Consumer staples and utilities were the top performing global equity sectors in April, while energy and health care underperformed. Actively-managed strategies have struggled to outperform their passive counterparts year-to-date, with the U.S. Mid Cap Value category experiencing the largest level of underperformance so far in 2025. On a rolling five-year basis, U.S. growth outperformance relative to value improved slightly from the previous month. Rolling five-year growth returns have consistently been ahead of value returns since 2017.	 The broad bond market, as represented by the Bloomberg U.S. Aggregate Bond Index, returned +0.39% in April, making it four consecutive months to begin the year in which the index posted positive return. Government-related sectors, both domestic and abroad achieved the top returns within the opportunity set, as the Bloomberg Global Treasury Index (ex U.S.) and the Bloomberg U.S. Government Index returned 1.64% and 0.63%, respectively. Risk-oriented assets lagged over the month with Emerging Market Debt returning -0.05%, and U.S. High Yield returning - 0.02%. In a reversal from the previous month, 10-year government bond yields of select countries were lower in April. Italy saw the largest decline, with the yield on its 10- year moving lower by 26 basis points(bps), followed by France (-24 bps), Germany (-24 bps) and the United Kingdom (-21 bps). In the U.S., the yield on the 10-year Treasury moved down by 5 bps, from 4.21% to 4.16%. For the third consecutive month, Municipal/Treasury ratios moved higher in April, with ratios across the curve increasing. Ratios on the front-end of the curve saw the largest increase, with two-year ratios moving higher by 12%. Ratios at the two-year and ten-year tenors are in-line with its five-year averages, while three-, five- and seven-year tenors are below its historical average.



- The U.S. unemployment rate held steady at 4.2% in April.
- Year-over-year U.S. core inflation has slowly moderated but remains above Federal Reserve targets. Inflation in Europe has leveled out recently at aboveaverage levels, while inflation in Japan is relatively low.
- U.S. industrial production growth was negative in March but remains moderately positive year-over-year. U.S. labor productivity declined in the first quarter, bringing the year-over-year rate back below 2%.











Fixed Income Spreads and TIPS Breakeven







 Higher VIX levels may be indicative of higher equity risk premiums.



Core Consumer Price Index (CPI): a measure of the aggregate price level in an economy, excluding certain volatile items.

Consumer Confidence Index (CCI): measures what consumers are feeling about their expected financial situation, whether that's optimistic or pessimistic.

Option Adjusted Spread (OAS): A bond's yield spread over comparable maturity government bonds, adjusted for any embedded options.

Real Disposable Personal Income: the amount of money that an individual or household has to spend or save after federal, state, and local taxes and other mandatory charges are deducted.

Real GDP: Real gross domestic product (GDP) is an inflation-adjusted measure that reflects the value of all goods and services produced by an economy in a given year, expressed in base-year prices.

Nonfarm payroll refers to the number of jobs in the private sector and government agencies. It excludes farm workers, private household employees, proprietors, non-profit employees, and actively serving military.

Revenue-to-Firm Value: Total Index Revenues of the past 12 months divided by the sum of equity market value and the value of total debt. This is a measure of total sales generated on the total value (debt plus equity) of firms in the index.

TIPS Breakeven: The inflation rate implied by the spread in yield between U.S. TIPS (Treasury Inflation Protected Securities) and nominal U.S. Government Bonds of equal maturity.

U.S. 3-Year Real Revenue Growth, Russell 3000 Non-Financials: For the Russell 3000 excluding financial firms, the percentage change in trailing 12-month inflation adjusted revenue over 12-month inflation adjusted revenue three years prior.

U.S. Cyclically Adjusted Earnings Yield: The 10-year average of annual, inflation adjusted earnings divided by the current inflation adjusted price of the S&P 500 index. This measure is the inverse of the Shiller CAPE Ratio.

YOY U.S. Productivity Growth: The year-over-year growth in real U.S. output produced per hour worked for non-farm workers.

CAPE Ratio: is a valuation measure that uses real earnings per share (EPS) over a 10-year period to smooth out fluctuations in corporate profits that occur over different periods of a business cycle.

Dividend Risk: refers to the risk of a stock's dividend being cut or eliminated, or to the risk to an option when a dividend is paid.

Dividend Yields: is a financial ratio that shows how much a company pays out in dividends each year relative to its stock price.

Eurozone: consists of those Member States of the European Union that have adopted the euro as their currency.

Municipal Yield: the annual return an investor receives on a municipal bond. It's calculated based on the bond's purchase price, coupon rate, and how long the investor holds the bond.

Treasury Yield: the interest rate the U.S. government pays on its debt securities, expressed as a percentage. It's also the annual return investors earn from holding a U.S. government security.

Capitalization/Style Returns: Capitalization/Style returns are based on the S&P Indexes. All values are cumulative total return for stated period including the reinvestment of dividends.
