## **Bond Market Review**

December 9, 2024

### **Summary**

The Federal Reserve is expected to cut the Fed Funds rate by 25 basis points next week after the recent data on the labor market showed continued cooling. However, we expect a slower pace of rate cuts and a higher neutral rate as inflation progress has stalled and Trump's proposed fiscal policies could put upward pressure on prices.

#### **Corporates Stable Heading Into Year-End**

• Investment grade corporates continued their recent holding pattern where spreads moved mostly sideways as we head into the end of the year. Dealer inventories increased due to a rise in selling activity, but positive retail inflows helped to offset this. Sector level performance also reflects stability with outperformers and underperformers both showing minimal dispersion.

### **Uneventful Week in High Yield**

The high yield corporate market was also uneventful as spreads were 3 basis points tighter with lower quality segments lagging slightly. Valuations remain at tight levels as option-adjusted spreads are just 6 basis points above the post-1997 low. With the recent rally in Treasuries, yields have declined slightly but remain attractive at slightly above 7% in our view.

### **Strong Week for Municipals**

It was a strong week in our view for tax-exempt munis as investors rushed to reinvest recent maturity proceeds and make final adjustments to portfolios before liquidity potentially decreases in the final weeks of the year. Month-to-date the ICE BofA 1-10 Year Index has produced a 0.26% total return with an excess return of 17 basis points. Duration has been the primary driver of returns as yields declined across the curve.

#### San Francisco Projects Budget Deficit

San Francisco is projecting an \$876M budget shortfall over the next two fiscal years. As a result, Mayor London Breed is instituting a 15% across-the-board spending reduction in all city departments. The city continues to struggle with a sluggish recovery of its hotel and business tax base with expenditures that continue to outpace revenues.

Technical Terms: Duration: a tool used in assessing the price volatility of a fixed-income security. Gross Domestic Product (GDP) A comprehensive measure of U.S. economic activity. GDP measures the value of the final goods and services produced in the United States (without double counting the intermediate goods and services used up to produce them). The federal funds rate is the interest rate at which depository institutions (mainly banks) lend reserve balances to other depository institutions overnight on an uncollateralized basis.
