Valuations and performance are reported in U.S. dollars. Periodic time weighted returns are geometrically linked. Returns are not calculated net of non-reclaimable withholding taxes due to immaterial dollar amounts. Effective 1/1/22, composite returns are calculated by weighting the individual portfolio returns using beginning of period market values. Prior to 1/1/22, composite returns were asset weighted using the aggregate method that reflects both beginning market value and cash flows.
- 7. Gross of fees returns are presented before management fees but after all trading costs. The net of fees returns reflect the maximum ADV management fee and trading costs. The stated fee schedule is: 0.85% on the first \$10 million, 0.70% on the next \$15 million, and 0.60% on all incremental assets above \$25 million on an annual basis as described in SCM's Form ADV, Part 2A.
- 8. Effective 7/1/07 the minimum initial portfolio size for inclusion in the composite is \$3 million. The appropriate benchmark is the Russell MidCap<sup>®</sup> Value Index which consists of stocks from the Russell MidCap<sup>®</sup> Index with a less than average growth orientation and lower price-to-book ratios. It represents the universe of stocks from which value managers typically select. The index is reconstituted annually. Total return includes price appreciation/depreciation and income as a percent of original investment.
- 9. The annual composite dispersion presented is measured by an asset-weighted standard deviation calculation method of all portfolios in the composite for the entire year, and is calculated using gross of fee returns. It is not meaningful when there have been less than six portfolios in composite for entire calendar year. The three year annualized standard deviation measures the variability of the composite and benchmark returns over the preceding 36-month period. The composite 3-year standard deviation is calculated using gross of fee returns. It is not required to be presented when a full three years of composite performance is not yet available.
